Before: GOODWIN, SCHROEDER, and TASHIMA, Circuit Judges. 1 MEMORANDUM\*\* 2 Roy Edward McGuire appeals the district court's order revoking his supervised release and imposing his original sentence of a term of imprisonment followed by the original term of supervised release. McGuire contends that the district court failed to comply with Federal Rule of Criminal Procedure 32(c)(3)(D) when it determined that there was a factual basis for his plea of guilty to bank fraud. We have jurisdiction pursuant to 28 U.S.C. § 1291. We review de novo the district court's compliance with the requirements of Rule 32(c)(3)(D) and United States v. Real, 1997 WL 702315 at \* 1 (9th Cir. Oct. 27, 1997). We affirm. 3 Pursuant to Federal Rule of Criminal Procedure 32(c)(3)(D), "[p]rior to the imposition of sentence, the court must verify that the defendant and defendant's counsel have read and discussed the presentence report...." The district court must make a finding that, with regard to each factual allegation in the report "which is not specifically admitted by the defendant, there is an adequate factual basis for the conclusion that the defendant actually committed the offense to which he is admitting." Fed.R.C
